- **Keep BUY and MYR1.92 TP, implying 26% upside and c.5% FY22F yield (31% total return).** Results were broadly in line with expectations. While the SOPs and tough operating environment are deterrents to a full-blown recovery, we still believe IGB REIT is an attractive recovery proxy, due to its asset quality, shopper profile, and rental structure. Trading at 1.34x FY22F P/B, or -2SD below its 5-year mean, its attractive valuation presents an opportunity to accumulate.
- **Within expectations.** 4Q21 core profit of MYR73.6m (+91% QoQ, -2.1% YoY) brought the full-year figure to MYR200.1m. The results were broadly in line with expectations, at 98-104% of our and Street's consensus. 4Q21 revenue grew by 24.6% QoQ from the resumption in business activities, following Phase 3 of the National Recovery Plan, which resulted in lower rental support granted for the quarter. 4Q21 earnings grew by 91% QoQ, supported by lower property operating expenses. YoY, FY21 revenue was 14.1% lower, while core earnings were down 15.5%, as rental support was at a larger quantum in FY21 vs FY20. A 2.17 sen DPU was declared for the quarter (4Q20: 2.08 sen), bringing FY21 DPU to 6.03 sen (FY20: 6.75 sen).
- **Looking forward to a recovery in reversion rates.** We gather that 4Q21 saw footfall teetering between the 80-85% mark of pre-pandemic levels, supported largely by the year-end festivities and pent-up demand. While occupancy rates remain very strong for both Mid Valley Mall (MVM) and The Gardens Mall (TGM), at close-to-full occupancy as at Dec 2021, management guided that FY21 reversion rates were flattish-to-negative (from positive mid-single digit pre-MCO). Notwithstanding the robust occupancy rates, we believe rental reversion will not return to pre-pandemic levels, as recovery for tenants is not equal. Nevertheless, we gather that half of the tenancies up for expiry in FY22 have already been renewed.
- **Staying optimistic, albeit cautiously.** While we like IGB REIT as a recovery proxy – given its largely domestic shopper profile and big turnover rent portion among the REITs under our coverage, at >10% (that should allow it to continue reaping the benefits of a pick-up in tenant sales) – we believe that rental assistance is likely to stay, as the recovery pace differs between tenants, and SOPs remain intact for the foreseeable future.
- **Quality assets for relatively cheap.** The market value of MVM and TGM remains at MYR3.7bn and MYR1.3bn despite the tough operating environment in the past two years – a testament to the assets' quality. That said, IGB REIT is trading at 1.34x forward P/B which is -2SD from the mean, rendering the REIT relatively cheaper than its pre-pandemic level, when it traded at a premium, at +2SD above the mean – presenting a good opportunity to accumulate.
- **Earnings forecasts unchanged.** Our TP stays at MYR1.92, with a 2% ESG premium, given its 3.1 ESG score, which is above the country median.

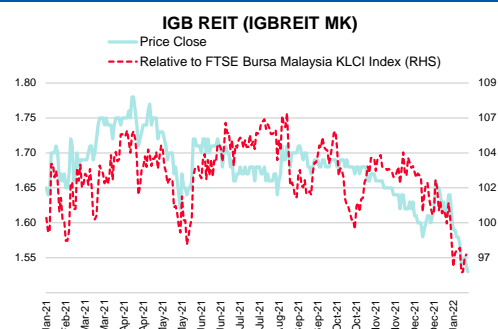

Recommendation Chart

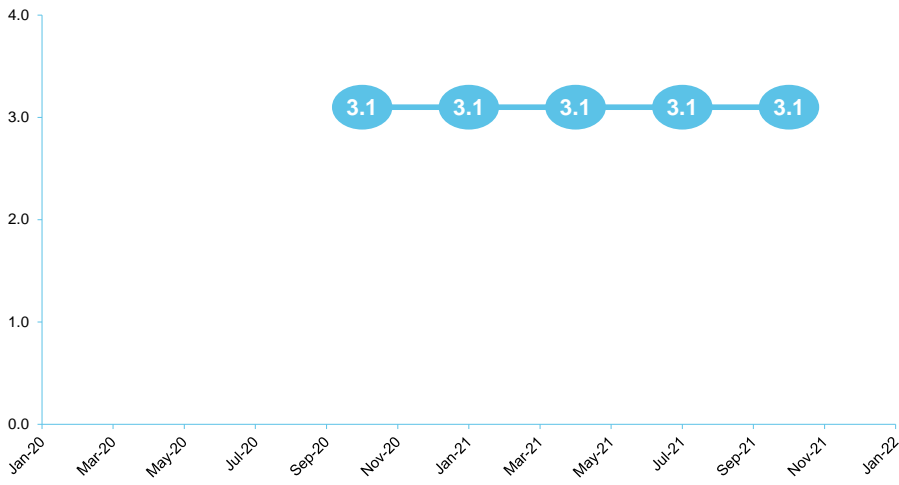
